

RESOLUTION NO. 123 S-2019

A RESOLUTION SUSPENDING THE MOTORIZED TRICYCLE OPERATOR'S PERMIT (MTO) IN THE MUNICIPALITY OF GUBAT OF ROGELIO E. VILLAREY WITH CASE NUMBER 05-09-388 AND JHOY B. VILLAREY WITH CASE NUMBER 05-09-3115 FOR A PERIOD OF ONE (1) YEAR STARTING THIS MONTH OF JUNE 2019.

WHEREAS, the Code of General Ordinances of the Municipality requires that any operator wishing to suspend service for more than one (1) month should apply in writing, subject to approval of the sangguniang bayan;



WHEREAS, the above-named applicant applied before this office for the suspension of their MTOP for reason that their public-utility-tricycle is under repair;

WHEREAS, the sangguniang bayan finds the request for suspension to be proper and reasonable;

NOW, THEREFORE, on motion of Honorable Cesar D. Esperida, Jr. and duly seconded by Honorable Ramon E. Entico, it was;


RESOLVED, as it is hereby resolved to suspend the Motorized Tricycle Operators Permit (MTOP) in the Municipality of Gubat of the above named applicant for a period of one (1) year starting this month of June 2019;

RESOLVED FURTHER, that this suspension of franchise has the effect of exempting the applicant from paying parking fee starting June 2019;
