

WHEREAS, the above named applicants for accreditation had submitted and complied with all the pertinent papers relevant to accreditation;


NOW THEREFORE, on motion of Honorable Ramon E. Entico and duly seconded by Honorable Cesar D. Esperida, Jr., it was;
