WHEREAS, the same Code further states that, The minimum number of regular session shall be once a week for the xxxxxxxx sanggunian bayan xxx;

NOW, THEREFORE, on motion of Honorable Alvin E. Rosales and unanimously seconded, it was;

RESOLVED, as it is hereby resolved to fix the regular sessions of the Sanggunian Bayan of the Municipality of Gubat, Sorsogon every Monday, at 8:30 in the morning, at the Sanggunian Bayan Session Hall, SB Building, Municipal Compound, Gubat, Sorsogon with temporary address at the Gubat Public Library Building, BU Compound, Rizal Street, Pinontingan, Gubat, Sorsogon, except on the first Mondays of the months with Five (5) Mondays;

RESOLVED FURTHER, that when public interest so demands, special sessions maybe called by the local chief executive or by a majority of the members of the sanggunian,

RESOLVED FURTHERMORE, that if a holiday falls on Monday, the session shall be held the following day;

RESOLVED FINALLY, that copies of this resolution be furnished all concerned for information and guidance
