A RESOLUTION AUTHORIZING HON. SHARON ROSE G. ESCOTO, MUNICIPAL MAYOR, TO ENTER INTO RS CONTRACT OF SERVICE WITH THE DEPARTMENT OF HEALTH (DOH) AND MS. CATHERINE F. ESCALORA REGARDING THE TWO-YEAR MIDWIFERY SCHOLARSHIP PROGRAM AWARDED TO THE LATTER.

WHEREAS, Republic Act No. 7160, otherwise known as the Local Government Code of 1991 states that the functions and responsibilities for the delivery of basic health services and other related facilities have been devolved from the Department of Health (DOH) to the Local Government Units;

WHEREAS, the Department of Health (DOH), pursuant to its mandate shall provide adequate and appropriate human resources for health services in marginalized areas, to include delivery of quality healthcare services to local government units such as the management of clinical, administrative, and in public health aspects;

WHEREAS, the Local Government Unit of Gubat in partnership with the Department of Health (DOH) agrees to become a priority area in the implementation of Rural Health Midwives Placement Program for a period of four (4) years;

WHEREAS, Ms. Catherine F. Escalora, in consideration of the scholarship awarded to her, hereby agrees to serve as a Rural Health Midwife (RHM) "as per return service" to this municipality in pursuant to the two (2)-year Midwifery Scholarship Program (MSPP);

WHEREAS, there is a need to authorize the Local Chief Executive to enter into RS Contract of Service to the above concerned parties to strengthened partnership and for more effective implementation of the program;


NOW THEREFORE, on motion of Hon. Valentin A. Pura IV and duly seconded by Hon. Cesar D. Esperida, Jr., it was;
