
NOW, THEREFORE, on motion of Honorable Valentin A. Pura IV and duly seconded by Honorable Alvin E. Rosales, it was;

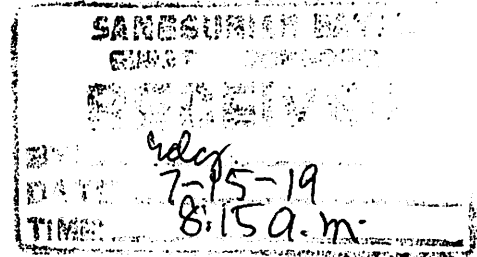

MDC EXECOM RESOLUTION NO. 3 S-2019

A RESOLUTION RECOMMENDING TO THE SANGGUNIANG BAYAN OF GUBAT THE APPROVAL OF THE REPROGRAMMING OF VARIOUS PROJECTS AMOUNTING TO SEVEN MILLION TWO HUNDRED AND SIXTY THOUSAND PESOS (P7,260,000.00) INTO (1) CONCRETING OF BARANGAY ROAD IN SITIO TINGTING, BARANGAY TIRIS (P1,000,000.00), (2) CONCRETING OF BARANGAY ROAD IN PUROK 1 CENTRO IN BARANGAY SAN IGNACIO (P400,000.00), (3) IMPROVEMENT OF PAMANA TERMINAL IN BARANGAY PARADIJON (P3,010,000.00), (4) IMPROVEMENT/REHABILITATION OF MARKET BUILDING 1 (WET SECTION) IN BARANGAY LUNA-CANDOL (P1,150,000.00), (5) PURCHASE OF NEWBORN HEARING SCREENING TEST (ADDITIONAL FUND) FOR USE AT THE MUNICIPAL HEALTH OFFICE IN BARANGAY PINONTINGAN (P200,000.00), AND (6) INSTALLATION OF SOLAR POWER FOR WATER SYSTEM AT THE PUBLIC MARKET IN BARANGAY LUNA-CANDOL (P1,500,000.00)

WHEREAS, Section 111 of the Local Government Code states that an Executive Committee shall be created to represent and act on behalf of the municipal Development Council particularly on matters requiring immediate action or attention of the Council;

WHEREAS, the Municipal Treasurer and the Municipal Accountant had jointly certified (Annex A) to the availability for reprogramming of Seven Million Two Hundred and Sixty Thousand Pesos (P7,260,000.00) the sources of which are the following unimplemented projects: Floating House for River Cruise in the barangays of Tiris and Cogon--P1,000,000.00, Loan Amortization--P3,220,000.00, Construction of Water System with Installation of Solar Power in the Public Market located in Barangay Luna-Candol--P1,500,000.00, Provision of Alternative Energy or Power Source at the Municipal Health Office in Barangay Pinontingan--P790,000.00, and Acquisition of Land for Barangay Site of Barangay Manook--P750,000.00;

WHEREAS, the Executive Committee of the Municipal Development Council met on July 10, 2019 and agreed to reprogram the aforementioned unimplemented projects into (1) Concreting of Barangay Road in Sitio Tingting, Barangay Tiris (P1,000,000.00), (2) Concreting of Barangay Road in Purok 1 Centro in Barangay San Ignacio (P400,000.00), (3) Improvement of PAMANA Terminal in Barangay Paradijon (P3,010,000.00), (4) Improvement/Rehabilitation of Market Building 1 (Wet Section) in Barangay Luna-Candol (P1,150,000.00), (5) Purchase of Newborn Hearing Screening Test (Additional Fund) for use at the Municipal Health Office in Barangay Pinontingan (P200,000.00), and (6) Installation of Solar Power for Water System at the Public Market in Barangay Luna-Candol (P1,500,000.00);

NOW, THEREFORE, on motion of Kagawad Valentin A. Pura IV and duly seconded by Punong Barangay Ramilo S. Fajardo, it was
