

RESOLUTION NO. 134 S - 2019

A RESOLUTION RESPECTFULLY REQUESTING THE LANDBANK OF THE PHILIPPINES (LBP), SORSOGON BRANCH, TO INSTALL AUTOMATED TELLER MACHINE (ATM) IN THE MUNICIPALITY OF GUBAT, SORSOGON TO CATER THE PANTAWID PAMILYANG PILIPINO PROGRAM (4P'S) BENEFICIARIES AND GOVERNMENT RETIREES OF GUBAT, SORSOGON AND ITS ADJACENT MUNICIPALITIES.

WHEREAS, in connection with the nation-wide issuance of ATM Cards for cash transfer and/or pay-out requirement of the beneficiaries of Pantawid Pamilyang Pilipino Program (4Ps) by the Department of Social Welfare and Development (DSWD), the need for additional ATM machines are likewise necessary;



WHEREAS, the beneficiaries of Pantawid Pamilyang Pilipino Program (4Ps) and government retirees in the Municipality of Gubat, Sorsogon are presently withdrawing their cash transfer in Sorsogon City where Landbank ATM's are only available;

WHEREAS, considering the additional burden imposed to our 4P's beneficiaries and government retirees, in terms of fare expenses and the inconvenience they suffered for reason of long waiting time before they can avail the services of ATM;

WHEREAS, in order to unload these beneficiaries to such burden, this local government unit finds it appropriate to make Landbank ATM available at this municipality and likewise extend its services to the 4P's beneficiaries and government retirees from the nearby municipalities of Barcelona, Bulusan and Casiguran;


NOW THEREFORE, on motion of Hon. Danilo J. Pura and unanimously seconded, it was;

RESOLVED, as it is hereby resolved, to respectfully request the Landbank of the Philippines (LBP), Sorsogon Branch, to install Automated Teller Machine (ATM) in the Municipality of Gubat, Sorsogon to cater the 4P's beneficiaries and government retirees of Gubat, Sorsogon and its adjacent municipalities;

RESOLVED FURTHER, that copy of this resolution be furnished the Branch Manager of Landbank of the Philippines (LBP), Sorsogon Branch, Sorsogon City, for their favorable action; Hon. Sharon Rose G.
