RESOLUTION NO. 135 S - 2019

A RESOLUTION ENJOINING ALL BARANGAY CAPTAINS, THIS MUNICIPALITY, TO REGISTER PERSONS WITH DISABILITIES (PWD's) RESIDING WITHIN THEIR RESPECTIVE TERRITORIAL JURISDICTION.

WHEREAS, Article 15 of the 1987 Constitution of the Republic of the Philippines includes disabled persons as one of the priority sectors to be given access to essential goods and services at affordable cost; and further provides, that the State shall establish a special agency for disabled persons for their rehabilitation, self-development and self-reliance, and their integration into the mainstream of the society;

WHEREAS, Chapter 8 of Republic Act No. 9442, also known as the "Magna Carta for Disabled Persons", in consonance with Section 35 (A) of the National Internal Revenue Code, entitle PWD's to at least 20% discount from purchases of goods and services;

WHEREAS, in order to avail these privileges and incentives, PWD's must be registered and be issued with identification cards (ID) by the Local Government Unit where they are residing;

NOW, THEREFORE, on motion of Honorable Alvin E. Rosales and duly seconded by Honorable Valentin A. Pura IV, it was;

RESOLVED, as it is hereby resolved to enjoin all barangay officials, this municipality, to register Persons with Disabilities (PWD's) residing within their territorial jurisdiction,

RESOLVED FURTHER, that copies of this resolution be furnished the Municipal Social Welfare and Development Office, Gubat, Sorsogon; the 42 Barangay Captains, Gubat, Sorsogon; the Community Rehabilitation Volunteers (CRV) of 42 barangays and all other concerned for their information and guidance.
