A RESOLUTION AUTHORIZING HON. SHARON ROSE G. ESCOTO, MUNICIPAL MAYOR, TO ENTER INTO MEMORANDUM OF AGREEMENT (MOA) WITH THE CASA MIANI "AUGUSTA & PIERA" (SOMASCANS FATHERS) FOUNDATION, INC. FOR THE CARE OF ABANDONED, NEGLECTED, ORPHANS, DEPENDENT AND NEEDY YOUTH AND SCHOOL AGE MINORS IN THE MUNICIPALITY OF GUBAT, SORSOGON

WHEREAS, the Local Government Unit of Gubat will enter into Memorandum of Agreement (MOA) with the Casa Miani Foundation, Inc. for the entrusting of abandoned, neglected, orphans, dependent and needy youth and school age minors identified and referred by the Municipal Social Welfare and Development Office (MSWDO);

WHEREAS, this local government unit as party to the MOA assures financial counterpart in the amount of Seven Hundred Pesos (P700.00) per admitted client to the shelter which amount will be used for education (tuition fee, books & misc.) food, clothing, shelter, medical and dental treatment of the admitted client;

WHEREAS, this local government unit is aware of the noble cause of the program being part of its social responsibility to care for the abandoned, orphans and neglected minors of the municipality;

WHEREAS, this local government unit finances is not yet capable of establishing and sustaining funds for the operation of its own centers and facilities for the care of said minors, therefore, there is a necessity to have partnership with NGOs and foundation for this purpose.


NOW THEREFORE, on motion of Honorable Alvin E. Rosales and duly seconded by Honorable Kenneth D. Escandor, it was;
