A RESOLUTION URGENTLY REQUESTING MR. DOMINGO S. SANTIAGO, JR, GENERAL MANAGER, SORECO II, BUHATAN, SORSOGON CITY AND ENGR. WILFREDO D. FLORES, OIC- ASST. DISTRICT ENGINEER, DPWH SORSOGON 2ND DISTRICT ENGINEERING OFFICE, PAYAWIN, GUBAT, SORSOGON, TO CAUSE THE IMMEDIATE REMOVAL/RELOCATION OF THE ELECTRICAL POLE GUY WIRES LEFT BEHIND ALONG ARIMAN-BENTUCO NATIONAL ROAD AFTER THE ROAD WIDENING AND LIKEWISE CAUSE THE CEMENTING OF HOLLOW SPACE LEFT AFTER ITS REMOVAL.

WHEREAS, it has been noted that electrical pole guy wires were left behind after the road concreting/widening of Ariman-Bentuco National Road for almost one (1) year which considerably poses great danger to the pedestrians and motorists using the said road;

WHEREAS, reports of incidents from pedestrians and motorists were already received by this office, thus, there is an urgent need to cause the immediate removal of these electrical pole guy wires along Ariman-Bentuco National Road to avoid worst accidents in the future that may results to lost of lives and properties;

WHEREAS, this request is likewise in response to the Presidential Directive of President Rodrigo R. Duterte through DILG Memorandum Circular No. 2019-121, to clear the roads of illegal structures and constructions and/or reclaim the road from any form of obstructions;


NOW THEREFORE, on motion of Hon. Danilo J. Pura and unanimously seconded, it was;

RESOLVED, as it is hereby resolved, to earnestly request Mr. Domingo S. Santiago, Jr., General Manager, SORECO II, SORECO II Compound, Buhatan, Sorsogon City and Engr. Wilfredo D. Flores, OIC - Asst. District Engineer, DPWH 2nd Engineering District, to cause the immediate removal/relocation of the electrical pole guy wires left behind along Ariman-Bentuco National Road after the road widening and likewise cause the cementing of hollow space after its removal;
