A RESOLUTION AUTHORIZING HON. SHARON ROSE G. ESCOTO, MUNICIPAL MAYOR, TO ENTER INTO MEMORANDUM OF AGREEMENT (MOA) WITH THE CEREBRAL PALSY ASSOCIATION OF SORSOGON (CPAS) WITH REGARDS TO THE USE, OCCUPANCY AND RIGHT OF MANAGEMENT OF THE MAREKAS BUILDING OWNED BY THIS MUNICIPALITY AS THE CPAS SATELLITE PHYSICAL THERAPY CLINIC.

WHEREAS, this Sanggunian Bayan in response to the mandate of the Local Government Code of 1991 for the care of the sick and disabled persons under Sec. 447, par. 5 (xiv), desires to entrust the use, occupancy and right of management of the MAREKAS building owned by this municipality to the Cerebral Palsy Association of Sorsogon;

WHEREAS, the use, occupancy and right of management of the said MAREKAS building requires this local government unit to enter into Memorandum of Agreement in order to define its duties and responsibilities thereto;


NOW THEREFORE, on motion of Hon. Alvin E. Rosales and unanimously seconded, it was;
