
RESOLUTION NO. 148 S-2019

A RESOLUTION AUTHORIZING HON. SHARON ROSE G. ESCOTO, MUNICIPAL MAYOR, TO ENTER INTO CONTRACT WITH SORSOGON II ELECTRIC COOPERATIVE (SORECO II) FOR THE SOLE USE OF TRANSFORMER.

WHEREAS, the Local Government Unit of Gubat is applying for the installation of one (1) unit 50 KVA Power Transformer to Sorsogon II Electric Cooperative for its exclusive use;

WHEREAS, said power transformer will be installed for the power maintenance and consumption of Gubat Public Library;

WHEREAS, this LGU undertakes to comply with all the terms and conditions set forth in the Contract, the same being fair and reasonable to both parties;
