RESOLUTION NO. 149 S-2019

A RESOLUTION AUTHORIZING HON. SHARON ROSE G. ESCOTO, MUNICIPAL MAYOR, TO ENTER INTO MEMORANDUM OF AGREEMENT (MOA) WITH THE PROVINCIAL GOVERNMENT OF SORSOGON REGARDING REMITTANCES OF THE MONTHLY SHARE OF THE PROVINCE FROM THE MUNICIPALITY OF GUBAT, SORSOGON COLLECTION FROM REAL PROPERTY TAXES

WHEREAS, the Provincial Government has a 35% share from the Basic Real Property Tax Collection and 50% share from SEF Real Property Tax Collection of the Municipalities;

WHEREAS, the Municipal Government of Gubat is authorized to collect imposition based on the existing provincial tax ordinance such as professional tax, amusement tax and other taxes;

WHEREAS, the shares in real property tax collection and provincial impositions collected by this municipality and accruing to the Province of Sorsogon shall be remitted to the latter's account;

WHEREAS, to facilitate remittances and to lessen the workload of the accountant and treasurer of the municipality, remittances of the monthly share of the Province from municipality's collection shall be done thru debits of the municipality's respective accounts based on the request of the Provincial Government;

WHEREAS, Memorandum of Agreement (MOA) between this local government unit and the Provincial Government of Sorsogon is necessary for the mutual understanding and compliance of the above undertakings;


NOW THEREFORE, on motion of Hon. Valentin A. Pura IV and duly seconded by Honorable Ramilo S. Fajardo, it was;

RESOLVED, as it is hereby resolved, to authorize Hon. Sharon Rose G. Escoto, Municipal Mayor, to enter into Memorandum of Agreement (MOA) with the Provincial Government of Sorsogon, regarding remittances of the monthly share of the province from the Municipality of Gubat, Sorsogon collection from the Real Property Taxes;
