### RESOLUTION NO. 159 S - 2019

A RESOLUTION AUTHORIZING HON. SHARON ROSE G. ESCOTO, MUNICIPAL MAYOR, TO REACTIVATE DORMANT ACCOUNTS OF THE LOCAL GOVERNMENT UNIT OF GUBAT, SORSOGON AT THE LANDBANK OF THE PHILIPPINES (LBP), SORSOGON BRANCH, SORSOGON CITY, DESIGNATING HON.
