

ESCOTO, MUNICIPAL MAYOR, AND THE PNP- 1ST SORSOGON PROVINCIAL MOBILE FORCE COMPANY REGARDING THE IMPLEMENTATION OF PROJECT SIDE FOREST IN BARANGAY TABI, GUBAT, SORSOGON.


