

A RESOLUTION EARNESTLY REQUESTING DIRECTOR SANDRA CAM, BOARD MEMBER, PHILIPPINE CHARITY SWEEPSTAKES OFFICE (PCSO), FOR ONE (1) UNIT OF AMBULANCE UNDER THE AMBULANCE DONATION PROGRAM FOR USE BY THE MUNICIPAL HEALTH OFFICE OF THE MUNICIPALITY OF GUBAT, PROVINCE OF SORSOGON.

WHEREAS, it is a mandatory duty of the State to protect and promote the right to health of every Filipino by making accessible quality and adequate health care to everybody, especially the poor and the disadvantage;

WHEREAS, the Municipality of Gubat, consisting of Forty Two (42) barangays with a total population of 62,632., operates a 4 bed - lying in operated and managed by the local government unit through the Municipal Health Office (MHO);



WHEREAS, this government health facility has only one (1) unit ambulance although serviceable, but unfortunately it is not enough to render adequate service to the people of Gubat especially those who are poor that cannot afford the high cost of transportation at the same time the hospitalization;

WHEREAS, with current increase in referral patients to Metro Manila, there is a necessity to acquire additional new ambulance and shall also serve as an standby for emergencies and other medical services during rescue operations during disasters and calamities;

NOW THEREFORE, on motion of Honorable Alvin E. Rosales and unanimously seconded, it was;


