NOW THEREFORE, on motion of Honorable Alvin E. Rosales and duly seconded by Honorable Valentin A. Pura IV, it was;



RESOLVED FURTHER, that copy of this resolution be furnished the Presidents of the aforementioned organizations, and others concerned for information and guidance.


