
NOW, THEREFORE, on motion of Honorable. Ramilo S. Fajardo and duly seconded by Honorable Valentin A. Pura IV, it was;

RESOLVED, as it is hereby resolved to approve the annual budget for FY 2019 of barangay Lapinig Gubat, Sorsogon;


