RESOLUTION NO. 192 S-2019

A RESOLUTION AUTHORIZING HON. SHARON ROSE G. ESCOTO, MUNICIPAL MAYOR, TO ENTER INTO MEMORANDUM OF AGREEMENT (MOA) WITH THE NATIONAL FOOD AUTHORITY, SORSOGON FIELD OFFICE, WITH REGARDS TO RICE LOAN AGREEMENT FOR THE DISASTER PREPAREDNESS PROGRAM OF THIS MUNICIPALITY.

WHEREAS, this local government unit is task under the law to ensure the delivery of basic services including relief assistance in times of calamities;

WHEREAS, part of the disaster preparedness program of this municipality is to ensure the availability and adequate supply of rice during the occurrence of calamities and other emergency needs;

WHEREAS, the National Food Authority (NFA), a government agency charged with the supply and distribution of grains, hereby grant the request of this municipality to purchase rice on credit for its relief operations under the terms and conditions set forth in a Rice Loan Memorandum of Agreement;

WHEREAS, sec. 22, par (c) of the Local Government Code of 1991 mandates the Local Chief Executive to secure authority from the sanggunian bayan concerned before entering into similar contract;

NOW THEREFORE, on motion of Hon. Danilo E. Enaje and unanimously seconded, it was:

RESOLVED, as it is hereby resolved to authorize Hon. Sharon Rose G. Escoto, Municipal Mayor, to enter into Memorandum of Agreement (MOA) with the National Food Authority, Sorsogon Field Office, with regards to Rice Loan Agreement for the Disaster Preparedness Program of this municipality;


