### RESOLUTION NO. 193 S - 2019

A RESOLUTION ENDORSING MDC EXECOM RESOLUTION NO. 5, S-2019 TO THE NATIONAL ECONOMIC DEVELOPMENT AUTHORITY (NEDA), REGIONAL OFFICE V, LEGASPI CITY, VARIOUS IRRIGATION PROJECTS FROM THE DIFFERENT BARANGAYS OF THE MUNICIPALITY OF GUBAT, SORSOGON TO BE FUNDED UNDER THE 2021 REPAIR/RESTORATION/REHABILITATION OF EXISTING COMMUNAL IRRIGATION SYSTEMS (RRECIS) OF THE NATIONAL IRRIGATION ADMINISTRATION (NIA).

WHEREAS, MDC Execom Resolution No. 5, S-2019 recommends to the National Economic Development Authority, Regional Office NO. V, Legaspi City, identified irrigations projects to be funded under the 2021 Repair/Restoration/Rehabilitation of Existing Communal Irrigation Systems (RRECIS) of the National Irrigation

Administration (NIA), namely: Bagacay CIS in Barangay Bagacay (P3,000,000.00), Rizal CIS in Barangay Rizal (P2,000,000.00), Cubias CIS in Barangay Carriedo (P5,000,000.00), North West Carriedo CIS (P2,500,000.00, Naagtan CIS (P1,500,000.00) and Anibong Bulacao CIS (P2,500,000.00);

WHEREAS, the Local Government Unit of Gubat acknowledges the importance of the above irrigation projects in the provisions of farming by our riceland farmers;

NOW THEREFORE, on motion of Honorable Kenneth D. Escandor and unanimously seconded, it was;

RESOLVED, as it is resolved, endorsing MDC Execom Resolution No. 5, S-2019 to the National Economic Development Authority (NEDA), Regional Office V, Legaspi City, various irrigation projects from different barangays of the Municipality of Gubat, Sorsogon, to be funded under 2021 Repair/Restoration/Rehabilitation of Existing Communal Irrigation Systems(RRECIS) of the National Irrigation Administration (NIA);
