RESOLUTION NO. 194 S-2019

A RESOLUTION AUTHORIZING HON. SHARON ROSE G. ESCOTO, MUNICIPAL MAYOR, TO ENTER INTO TRIPARTITE MEMORANDUM OF AGREEMENT WITH ABS-CBN LINGKOD KAPAMILYA FOUNDATION, INC. (ALKFI) - BANTAY KALIKASAN (BK) AND DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES (DENR), REGION V, REGARDING MANAGEMENT OF THE FORESHORE AREA INFRONT AND ADJACENT (3,500 SQUARE METERS) OF LOLA SAYONG ECO-SURF CAMP IN BARANGAY BUENAVISTA, GUBAT, SORSOGON BY THE GUBATNON FOR ADVENTOURISM INC.

WHEREAS, the Gubatnon for Adventourism, Inc. is a people's organization managing the Lola Sayong Eco-Surf Camp in Barangay Buenavista, Gubat, Sorsogon united by passion of surfing and conservation of the environment, creating responsible job opportunities for the locals, and with an advocacy of providing better direction for the out-of-school youth against negative influences of the society, and further committed to its goal of sound stewardship for sustainable eco-tourism and conservation;

WHEREAS, from the year 2014, the ABS-CBN Lingkod Kapamilya Foundation, Inc. (ALKFI) through its environmental arm, Bantay Kalikasan (BK) has engaged with the above named people's organization in developing a sustainable eco-tourism enterprise as a strategy to achieve its community mission;

WHEREAS, to strengthen the collaboration of ABS-CBN Lingkod Kapamilya Foundation, Inc. (ALKFI) with the Gubatnon for Adventourism Inc. in their shared mission to mobilize the community in protecting, conserving, and managing the environment and natural resources for the present and future generations, the ALKFI moved to have partnership with this local government unit and Department of Environment and Natural Resources (DENR), Region V, to help Lola Sayong Eco-Surf Camp secure the management of Foreshore Land pending its processing of Foreshore Lease Application;

WHEREAS, the Local Government Unit of Gubat adheres to the above undertaking as a significant tool in protecting and nurturing environment and rich biodiversity of the municipality, and as an effective avenue of eradicating poverty within the municipality by uplifting and improving the lives of its constituents through various creation of local enterprise and development programs brought about and associated with ecotourism and/or local tourism enterprise;


NOW THEREFORE, on motion of Honorable Anthony C. Callos and unanimously seconded, it was;


