A RESOLUTION SUSPENDING THE MOTORIZED TRICYCLE OPERATOR'S PERMIT (MTO) IN THE MUNICIPALITY OF GUBAT OF EDWIN D. ENCELA WITH CASE NUMBER 05-09-2370 AND RONNIE E. ERMITANO WITH CASE NUMBER 05-09-1358 FOR A PERIOD OF ONE (1) YEAR STARTING THIS MONTH OF OCTOBER 2019.

WHEREAS, the Code of General Ordinances of the Municipality requires that any operator wishing to suspend service for more than one (1) month should apply in writing, subject to approval of the sangguniang bayan;

WHEREAS, the above-named applicants applied before this office for the suspension of their MTO for reason that their public-utility-tricycle is under repair;

WHEREAS, the sangguniang bayan finds the request for suspension to be proper and reasonable;

NOW, THEREFORE, on motion of Honorable Noe L. Endaya, Jr. and duly seconded by Honorable Danilo J. Pura, it was;

RESOLVED, as it is hereby resolved to suspend the Motorized Tricycle Operators Permit (MTO) in the Municipality of Gubat of Edwin Encela with case number 05-09-2370 and Ronnie E. Ermitano with case number 05-09-1358 for a period of one (1) year starting this month of October 2019;

RESOLVED FURTHER, that this suspension of franchise has the effect of exempting the applicant from paying parking fee starting October 2019;

RESOLVED FURTHERMORE, that copies of this resolution be furnished Mr. Eman C. Flestado, Bicycle and Tricycle Permits Clerk-Designate, Office of the Mayor, the applicants and others concerned for their information and guidance.
