WHEREAS, the Local Government Unit of Gubat, Sorsogon has the following list of priority projects included in the Annual Investment Plan for CY 2019 that needs immediate implementation, however, the municipality do not have sufficient funds to finance the huge amount required by each project:

1. Construction of Cabiguhan - Dita Farm to Market Road - P10 Million
2. Construction of Sitio Ariman, Bentuco - Farm to Market Road - P10 Million
3. Construction of Binilangan-Villareal Farm to Market Road - P10 Million
4. Construction of Multi-purpose Hall (Brgy. Balud del Sur) - P5 Million
5. Construction of Multi-purpose Hall (Brgy. Manook) - P5 Million

WHEREAS, this local government unit finds it appropriate to source out funds from national government agencies/department in order to augment funds needed for the implementation of the projects, and in order to achieve the goal of this local government unit in providing basic services and facilities to its constituents essential for their socio-economic development;


NOW THEREFORE, on motion of Honorable Danilo E. Enaje and duly seconded by Honorable Danilo J. Pura, it was;


