### RESOLUTION NO. 208 S - 2019

A RESOLUTION REQUESTING HONORABLE SHARON ROSE G. ESCOTO, MUNICIPAL MAYOR TO PROVIDE A TEMPORARY OFFICE FOR THE SANGGUNIANG KABATAAN MUNICIPAL FEDERATION WITH INFORMATION TECHNOLOGY EQUIPMENT, MATERIALS AND RESOURCES FOR USE IN THEIR OFFICIAL DUTIES AND FUNCTIONS.

WHEREAS, the State recognizes the vital role of the youth in nation-building and thus, promotes and protects their physical, moral, spiritual, intellectual and social well-being, inculcates in them patriotism, nationalism and other desirable values, and encourages their involvement in public and civic affairs.

WHEREAS, the State shall establish adequate, effective, responsive and enabling mechanisms and support systems that will ensure the meaningful participation of the youth in local governance and nation-building;

WHEREAS, Republic Act 10742 otherwise known as the Sangguniang Kabataan Reform Act specifically Section 8 (Letters a - j) and Section 13 (a - h) , clearly state the Powers and Functions of the Sangguniang Kabataan and the Sangguniang Kabataan Chairperson, respectively;

WHEREAS, the same law also mandates the creation of Local Youth Development Council and the Local Youth Development Office in every LGU and the latter shall incorporate in its annual budget such amount as may be necessary for the operation and effective functioning of the Local Youth Development Office.

WHEREAS, at present, the SK Municipal Federation has no office that can be utilized as venue for meetings, official transactions, official workplace and other youth activities;


NOW, THEREFORE, on motion of Honorable Norven E. Ariola and unanimously seconded, it was;


