WHEREAS, Municipal Ordinance No. 2014-005 under Section 2 (Section 22 (a) (1) as amended provides that, the operator is allowed to apply for a substitution of unit using the same unexpired MTOP/POP;

WHEREAS, after the approval of the amendment of the provisions of the Code of General Ordinances the substitution of unit is allowed to the operators having an unexpired franchise or Motorized Tricycle Operators Permit (MTOP);

NOW, THEREFORE, on motion of Honorable Cesar D. Esperida, Jr. and duly seconded by Honorable Kenneth D. Escandor, it was;

RESOLVED, as it is hereby resolved to approve the application of the above-named applicant for the substitution of unit of Motorized Tricycle in the Municipality of Gubat, Sorsogon;
