
RESOLUTION NO. 21 S - 2020

A RESOLUTION EARNESTLY REQUESTING HONORABLE MA. BERNARDITA B. RAMOS, REPRESENTATIVE, 2ND CONGRESSIONAL DISTRICT, PROVINCE OF SORSOGON TO INCLUDE IN HER PRIORITY PROJECTS FOR FUNDING UNDER THE GENERAL APPROPRIATIONS ACT, THE CONSTRUCTION OF SEAWALL/ PROTECTIVE BARRIER ALONG THE COASTLINE OF BARANGAY RIZAL, GUBAT, SORSOGON.

WHEREAS, the Municipality of Gubat is a second - class municipality belonging to the second congressional district of Sorsogon. It is located in the East Coast of the Province of Sorsogon;

WHEREAS, the municipality experiences maximum rainfall from November to January and is along the path of typhoons from the month of May to December;

WHEREAS, it is susceptible to storm surge covering 2,111.59 hectares and in case of tsunami, almost half of the barangays will be inundated as per study of the Municipal Planning and Development Office (MPDO);



WHEREAS, recently, when Typhoon "Tisoy" struck the municipality of Gubat, numerous beach cottages along the coastline of Barangay Rizal were destroyed hence, the construction of a seawall/protective barrier is of vital importance and a necessity to protect life and property;

WHEREAS, considering that the construction of this project requires huge amount of government funds, and the municipality is financially incapable to implement the same, thus, this request;


NOW, THEREFORE, on motion of Honorable Anthony C. Callos and unanimously seconded, it was;
