RESOLUTION NO. 213 S-2019

A RESOLUTION RECOGNIZING LOLA SAYONG ECO-SURF CAMP AS A CATALYST FOR THE PROMOTION OF ENVIRONMENTAL ADVOCACIES AND ECO-TOURISM IN THE MUNICIPALITY OF GUBAT, SORSOGON.

WHEREAS, Lola Sayong Eco-Surf Camp is one of the eco-tourism projects of the late Honorable Regina Paz O. Lopez, Former Secretary of the Department of Environment and Natural Resources (DENR) and Former Chairperson of ABS-CBN Foundation, and has been a catalyst for the promotion of environmental advocacies and eco-tourism in the Municipality of Gubat;

WHEREAS, Lola Sayong Eco-Surf Camp is a Community based eco-tourism social enterprise, established in 2014 through the assistance and partnership with ABS-CBN Foundation and their Chairperson, the late Honorable Regina Paz O. Lopez, which is a primary means of livelihood for 70 locals and corresponding households of Gubat, Sorsogon;

WHEREAS, Lola Sayong Eco-Surf Camp became a study hub for other social enterprise development and hosts numerous certification courses such as NC I and NC II of TESDA;

WHEREAS, Lola Sayong Eco-Surf Camp has played a vital role in the development of the eco-tourism industry in the Municipality of Gubat, Sorsogon such that it contributes to the economy of Gubat, Sorsogon by providing regular tourists such as surfers, outdoor enthusiasts, students and tourists seeking for nature experience and adventure anchored on Eco-tourism;

WHEREAS, Lola Sayong Eco-Surf Camp provides tourists with an eco-friendly advocacy filled surf camp and has been catalytic in strengthening the participation of both tourists and local communities in different environment related activities such as coastal clean-up, fund raising for environmental activities and conservation, sea turtle (pawikan) conservation, environmental awareness seminars and campaigns;

WHEREAS, said contributions of Lola Sayong Eco-Surf Camp deserves recognition and commendation for being a solid partner of this local government unit in the protection and conservation of environment, livelihood opportunities and promotion of eco-tourism in the municipality;
