A RESOLUTION EARNESTLY REQUESTING POLICE BRIGADIER GENERAL ARNEL B. ESCOBAL, PNP REGIONAL DIRECTOR, PHILIPPINE NATIONAL POLICE, PRO V, CAMP SIMEON OLA, LEGASPI CITY, ALBAY, FOR ADDITIONAL PNP PERSONNEL FOR THE GUBAT MUNICIPAL POLICE STATION (GMPS) OF GUBAT, SORSOGON.

WHEREAS, the Municipality of Gubat is comprised of forty-two (42) barangays and more or less 63,000 populations but only have twenty-one (21) numbers of PNP uniformed personnel that comprises the Municipal Police Station;

WHEREAS, in maintaining the local peace and order in the entire municipality, this local government unit is basically dependent on the presence or assistance of police personnel particularly on their task of eradicating crimes such as illegal drugs, illegal gambling and other petty crimes, and likewise in responding emergency cases during disasters and calamities;

WHEREAS, members of Philippine National Police (PNP) are considered partner of this local government unit in the enforcement of local ordinances, thus, their vigilance and involvement on the apprehension of violators is of great value and significant to the public order and safety of this municipality;

WHEREAS, the necessity of additional PNP personnel is being considered by this local government unit to augment the arm in fostering peace and order in the entire municipality;

NOW THEREFORE, on motion of Honorable Aiza E. Encinares and unanimously seconded, it was;

RESOLVED, as it is hereby resolved, earnestly requesting to Police Brigadier General Arnel B. Escobal, PNP Regional Director, Police Regional Office V, Camp Simeon Ola, Legaspi City, Albay, for additional PNP Personnel for the Gubat zmunicipal Police Station (GMPS) of Gubat, Sorsogon;
