A RESOLUTION URGENTLY REQUESTING ENGR. JOSE ERWIN R. TABUENA, GENERAL MANAGER, SORECO II, BARANGAY BUHATAN, SORSOGON CITY, FOR THE INSTALLATION OF THREE-PHASE LINE GOING TO TAGAYTAY DUMPSITE AREA NECESSARY FOR THE INSTALLATION AND OPERATION OF ITS REFUSED DERIVED FUEL (RDF) MACHINE.

WHEREAS, the Local Government Unit of Gubat is on the process of setting up the Refused Derived Fuel (RDF) machine for the municipal solid waste at Brgy. Tagaytay Dumpsite Area, Tagaytay, Gubat, Sorsogon;

WHEREAS, to facilitate the operation of this Refused Derived Fuel (RDF) machine, the need for a Three-Phase electrical power connection appropriate for its requirement is very much urgent and necessary;

WHEREAS, this local government unit is looking forward for the immediate completion or installation of this RDF machine to address the problem of segregation and recycling of municipal waste without having been sacrificing the negative impact to the environment;

NOW THEREFORE, on motion of Honorable Danilo J. Pura and duly seconded by Honorable Alvin E. Rosales and Honorable Ramilo S. Fajardo, it was;

RESOLVED, as it is hereby resolved, urgently requesting Engr. Mr. Jose Erwin R. Tabuena, General Manager, SORECO II, Barangay Buhatan, Sorsogon City, for the installation of three-phase line going to Tagaytay Dumpsite Area necessary for the installation and operation of the Refused Derived Fuel (RDF) machine;


