RESOLUTION NO. 227 S-2019

A RESOLUTION AUTHORIZING HON. SHARON ROSE G. ESCOTO, MUNICIPAL MAYOR, TO ENTER INTO MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF LABOR AND EMPLOYMENT (DOLE), SORSOGON PROVINCIAL FIELD OFFICE, REGARDING THE IMPLEMENTATION OF THE NATIONAL PROGRAM AGAINST CHILD LABOR (NPACL) AND REGIONAL ANTI-CHILD LABOR COMMITTEE (RACLC).

WHEREAS, the Local Government Unit of Gubat agrees and cooperate in the implementation of the National Program Against Child Labor (NPACL) and Regional Anti-Labor Committee (RACLC), an agency-member of the Provincial Anti-Child Labor Committee;

WHEREAS, such endeavour will enable this local government unit to intensify programs and campaign against child labor and primarily prevent children from engaging in worst forms of child labor, and further ensure that children so engaged will be afforded protection and totally withdrawn from it;

RESOLVED, as it is hereby resolved, to authorize Hon. Sharon Rose G. Escoto, Municipal Mayor, to enter into Memorandum of Agreement (MOA) with the Department of Labor and Employment (DOLE), Sorsogon Provincial Field Office, regarding the implementation of the National Program Against Child Labor (NPACL) and Regional Anti-Child Labor Committee (RACLC);
