RESOLUTION NO. 231 S-2019

A RESOLUTION DECLARING AS VALID AND ENFORCEABLE, BARANGAY STA. ANA ORDINANCE NOS. 2019-01, 2019-02 AND 2019-03.

WHEREAS, Barangay Sta. Ana has enacted the following regulatory ordinances numbered and titled as follows, to wit:

a. Brgy. Ordinance No. 2019-01, "Ang Ordinansang Ito na Nagbabawal sa mga Motor(Single) Tricycle at Iba Pang Mga Sasakyan na may Open Muffler";

b. Brgy. Ordinance No. 2019-02, "Ang Ordinansang Nagbabawal sa Pag Parking sa Piliw san Tinanpo na Inaabotan nang 12 Hanggang 24 Oras O Permanenteng Nakaparada sa Sakop San Brgy. Sta. Ana, Gubat, Sorsogon";

c. Brgy. Ordinance No. 2019-03, "An Ordinansa na Nagbabawal sa mga Tawo na Magpatindog Balay o Establisimiento sa Piliw o Solod san Pampublikong Lugar na Nasasakupan san Barangay Sta. Ana, Gubat, Sorsogon";

WHEREAS, Article 3, Section 391 (a) of the Local Government Code of 1991 states that, "The Sangguniang Barangay, as the legislative body of the barangay shall (1) enact ordinances as may be necessary to discharge the responsibilities conferred upon it by law or ordinance and to promote the general welfare of the inhabitants thereon";

WHEREAS, Section 447, par. (a), subpar. (1) the Sangguniang Bayan has the power and duties to "approved ordinances and pass resolutions necessary for an efficient and effective municipal government, and in this connection (i) Review all ordinances approved by the sangguniang barangay and executive orders issued by the punong barangay to determine whether these are within the scope of the prescribed powers of the sanggunian and the punong barangay;

WHEREAS, it has been found that in the enactment of the above-mentioned ordinances, proper procedure was observed and that the same are in consonance with the Local Government Code of 1991 and other pertinent laws and local ordinances;

NOW, THEREFORE, on motion of Honorable Alvin E. Rosales and duly seconded by Honorable Kenneth D. Escandor, it was;

RESOLVED, as it is hereby resolved to declare as valid and enforceable Barangay Sta. Ana Ordinance Nos. 2019-01, 2019-02 and 2019-03;

RESOLVED FURTHER, that copy of this resolution be furnished the barangay council of Sta. Ana and others concerned for information and guidance.
