WHEREAS, the Local Government Unit of Gubat supports programs, projects and activities of the members and organizations of lesbian, gay, bisexual and transgender (LGBT) as part of the municipality's Gender Ordinance that protects members of LGBT community from discrimination;

WHEREAS, the LGBT community is actively participating in all significant programs and activities of the municipality such as the promotion of tourism and socio-cultural activities, advocacy on the protection of environment, youth and sports development programs, and health and wellness program;

WHEREAS, this local government unit recognizes the contribution of this LGBT community being one of active community-based organizations in the municipality, thus, addressing their needs for venue or center to house the organization's meeting and own core programs and services, is of great achievement for this local government unit despite limited resources;

WHEREAS, the Local Government Unit of Gubat is looking forward to realize this project despite limited resources and considering further that the resources of this municipality was already allocated for other priority developmental projects, the need to source out funds from national agencies is the possible option perceived by this Sangguniang Bayan;

NOW THEREFORE, on motion of Hon. Aiza E. Encinares and unanimously seconded, it was;


