A RESOLUTION EARNESTLY REQUESTING HON. EMMANUEL "MANNY" PACQUIAO, SENATOR, REPUBLIC OF THE PHILIPPINES, FOR ONE (1) UNIT BOXING RING FOR THE LOCAL GOVERNMENT UNIT OF GUBAT, SORSOGON.

WHEREAS, the Local Government Unit of Gubat adheres to the policy of the State in the promotion and protection of the physical, moral, spiritual, intellectual and social well-being of the youth to the end that the youth realize their potential for improving the quality of life;

WHEREAS, in order to support above declared national policy, this local government unit focuses on youth sports development programs and delivery system in the municipality by providing them ample opportunity to sports and recreation programs despite limited financial capacity;

WHEREAS, one of the sports valued today by the youth is the boxing sport ideal for improving strength, endurance and balance, thus, becoming the center of sports events and recreations activity regularly sponsored by this local government unit;

WHEREAS, it is the aspiration of this local government unit to have a durable boxing ring to be used in its regular amateur boxing tournament in order to address the problem of regularly allocating funds needed for rentals of complete boxing ring;

WHEREAS, considering the limited financial capacity of this local government unit to purchase new boxing ring and considering further that the resources of this municipality was already allocated for other priority developmental projects, the need to source out funds and/or avail one from national agencies is the possible option perceived by this Sangguniang Bayan;

NOW THEREFORE, on motion of Hon. Aiza E. Encinares and unanimously seconded, it was;

RESOLVED, as it is hereby resolved, earnestly requesting Hon. Emmanuel "Manny" Pacquiao, Senator, Republic of the Philippines, for one (1) unit boxing ring for the Local Government Unit of Gubat, Sorsogon;
