RESOLUTION NO. 236 S-2019

A RESOLUTION EARNESTLY REQUESTING HON. GRACE POE, SENATOR, REPUBLIC OF THE PHILIPPINES, FOR ONE (1) UNIT OF AMBULANCE FOR THE USE OF THE MUNICIPALITY OF GUBAT, SORSOGON.

WHEREAS, it is the policy of the State to protect and promote the right to health of every Filipino by making accessible quality and adequate health care to everybody, especially the poor and the disadvantage;

WHEREAS, the Municipality of Gubat, consisting of Forty-Two (42) barangays, has only two (2) units of old ambulance although serviceable, but unfortunately it is not enough to render adequate service to the people of Gubat especially those who are poor that cannot afford the high cost of transportation and at the same time the hospitalization;

WHEREAS, to afford sound health services particularly those in emergency cases, the municipality is in need of additional one (1) unit of ambulance to be used particularly by the Municipal Health Office to ensure availability of transportation during referral of patients to distant hospitals and for emergencies and other medical services;

WHEREAS, funds of the Local Government Unit of Gubat is now insufficient to allocate fund necessary to purchase additional one (1) unit of ambulance considering that prior appropriation to other developmental projects were already made, thus, the municipality is of the option to resort other funding sources;


NOW THEREFORE, on motion of Hon. Noe L. Endaya and unanimously seconded, it was;

RESOLVED, as it is hereby resolved to earnestly Hon. Grace Poe, Senator, Republic of the Philippines, for One (1) Unit of Ambulance for the use of the Municipality of Gubat, Sorsogon;
