RESOLUTION NO. 24 S-2019

A RESOLUTION DECLARING AS VALID AND ENFORCEABLE, BARANGAY SAN IGNACIO ORDINANCE NO. 02-2018, "AN ORDINANCE PROHIBITING THE PRESENCE OF ASTRAY ANIMALS IN ALL PUBLIC PLACES WITHIN THE BARANGAY OF SAN IGNACIO, GUBAT, SORSOGON.

WHEREAS, Article 3, Section 391 (a) of the Local Government Code of 1991 states that, "The Sangguniang Barangay, as the legislative body of the barangay shall (1) enact ordinances as may be necessary to discharge the responsibilities conferred upon it by law or ordinance and to promote the general welfare of the inhabitants thereon";

WHEREAS, Section 447, par. (a), subpar. (1) the Sangguniang Bayan has the power and duties to "approved ordinances and pass resolutions necessary for an efficient and effective municipal government, and in this connection (i) Review all ordinances

approved by the sangguniang barangay and executive orders issued by the punong barangay to determine whether these are within the scope of the prescribed powers of the sanggunian and the punong barangay;

WHEREAS, it has been found that in the enactment of the above-mentioned ordinance, proper procedure were observed and that the same is in consonance with the Local Government Code of 1991 and other pertinent laws and local ordinances;

NOW, THEREFORE, on motion of Hon. Valentin A. Pura IV and duly seconded by Hon. Cesar D. Esperida, Jr. and Hon. Kenneth D. Escandor, it was;

RESOLVED, as it is hereby resolved to declare as valid and enforceable Barangay San Ignacio Ordinance No. 02-2018, "AN ORDINANCE PROHIBITING THE PRESENCE OF ASTRAY ANIMALS IN ALL PUBLIC PLACES WITHIN THE BARANGAY OF SAN IGNACIO, GUBAT, SORSOGON"


