

A RESOLUTION TO AUTHORIZE THE GRANT OF MONTHLY ALLOWANCES TO ATTY. VALENTIN A. PURA III AND ATTY. MARICEL N. OLBES, PUBLIC ATTORNEYS, PUBLIC ATTORNEY'S OFFICE (PAO), GUBAT DISTRICT OFFICE IN THE AMOUNT OF FIVE THOUSAND (P5,000.00) PESOS EFFECTIVE OCTOBER 14, 2019.

WHEREAS, Section 447 (a) (1) of the Local Government Code of 1991 states that "when the finances of the municipality allow, provide for additional allowances and other benefits to judges, prosecutors, public elementary and high school teachers and other government officials stationed in or assigned to the municipality";

WHEREAS, Department of Budget and Management (BDM) Compensation Policy Guidelines dated March 23, 1998, provides that, national government officials may collect additional compensation in the form of honorarium from the local government unit where they are assigned, as provided under Section 5.0 of LBC 62;


