RESOLUTION NO. 247 S-2019

A RESOLUTION EARNESTLY REQUESTING HONORABLE CHRISTOPHER LAWRENCE "BONG" GO, SENATOR, REPUBLIC OF THE PHILIPPINES, FOR THREE (3) UNITS OF DIALYSIS MACHINES FOR THE USE OF DIALYSIS PATIENTS OF THE MUNICIPALITY OF GUBAT, SORSOGON.

WHEREAS, the Municipality of Gubat, Sorsogon, has the highest incidence of dialysis patients in the Province of Sorsogon but only have two (2) private dialysis center with limited machines available to accommodate dialysis patients in the whole province, thus, most of the patients travel to Legaspi City for dialysis treatment;

WHEREAS, most of the patients, if not all, are poor Gubatnons who are trying their best to extend their lives and/or lives of their family members, to the point of selling their only property or even borrow money to sustain the expenses for dialysis treatment and to include the heavy burden of transportation expenses on the part of the patient

WHEREAS, providing three (3) dialysis machines would be a great relief to the patients who regularly undergo dialysis treatment in the Province of Albay due to limited dialysis machines that resulted to limited slots/schedule for dialysis treatment in the private dialysis center in the Province of Sorsogon;

WHEREAS, the possibility of acquiring dialysis machines is vital to the needs of our constituents who are dialysis patients, most especially those belonging to indigent families who cannot afford to travel to the Province of Albay and/or afford to pay the expense of availing the services of private dialysis center in the province;

NOW THEREFORE, on motion of Hoorable Noe L. Endaya and unanimously seconded, it was;


RESOLVED, as it is hereby resolved to earnestly request Honorable Christopher Lawrence "Bong" Go, Senator, Republic of the Philippines, for three (3) Units of Dialysis Machines for the use of Dialysis Patients of the Municipality of Gubat, Sorsogon;

RESOLVED FURTHER, that the said three (3) units of dialysis machines be installed at the Dr. Fernando Duran, Sr. Memorial Hospital, Sorsogon City, who has the capacity to treat dialysis patients as an augmentation to its Dialysis Center, but with the provision that dialysis patients coming from the Municipality of Gubat would be given the first priority to use the machine;

RESOLVED FINALLY, that copy of this resolution be furnished Honorable Christopher Lawrence "Bong" Go, Senator, Republic of the Philippines, GSIS Bldg., Financial Center, Diokno Boulevard, Pasay City, for his favorable action; Dr. Edgar Garcia, Chief, Dr. Fernando Duran, Sr. Memorial Hospital, Sorsogon City; and Honorable Sharon Rose G. Escoto, Municipal Mayor, LGU-Gubat, Sorsogon, for their information and guidance.
