RESOLUTION NO. 248 S - 2019

A RESOLUTION REQUESTING THE OFFICE OF THE MUNICIPAL MAYOR THROUGH MS. LEAH E. SANTOS, MARKET SUPERVISOR TO STRICTLY IMPLEMENT AND ENFORCE ORDINANCES ON THE MANAGEMENT AND OPERATION OF THE PUBLIC MARKET AND SUBMIT TO THIS OFFICE PERIODIC REPORT ON THE ACTION TAKEN THEREON.

WHEREAS, numerous ordinances were enacted and approved by the Sangguniang Bayan in relation to the management and operation of the Gubat Public Market and most recently was Municipal Ordinance No. 2019 - 003 or the "ORDINANCE PROVIDING GUIDELINES AND POLICIES ON THE MANAGEMENT AND OPERATION OF THE NEW PUBLIC MARKET BUILDING (C-SHAPED BUILDING), AND FOR OTHER PURPOSES";

WHEREAS, it came to the knowledge of the Sangguniang Bayan that violations on the rules and regulations specially the prohibitions on unauthorized vending; occupation of the passageways and alleys; cleanliness and sanitation and proper wastes disposal in the market premises are rampant and widespread;

WHEREAS, as clearly provided for under Section 12 of Municipal Ordinance No. 2019 -003, (ADMINISTRATIVE PROVISION) that, *(a) The Municipal Mayor shall exercise direct and immediate supervision, administration and control over the public market and its premises and the personnel thereof, including those whose duties concern the maintenance and upkeep thereof, in accordance with this Ordinance and other pertinent rules and regulations*";

WHEREAS, moreover, under Section 17 of the same ordinance further provides that, *"Any violations of the provisions of this Ordinance committed by any persons, stallholders or occupants, if proven after investigation, that the violators are in cahoots or in connivance with her or any of her duly authorized representatives, and any employees of this LGU, the market supervisor and the employees concerned shall also be held responsible for the violations and she/he shall be meted appropriate disciplinary actions under existing laws"*

WHEREAS, Republic Act 7160 otherwise called the Local Government Code of 1991 directs the legislative body to exercise its oversight function in accordance with the principle of checks and balance which refers to monitoring, examination and investigation in aid of legislation;

WHEREAS, the Sangguniang Bayan, invoking its oversight power, is mandated to know *what* the executive is doing; *how* programs are being administered, *by whom*, and *at what cost*; and whether officials are obeying the law and complying with its legislative intent;


NOW, THEREFORE, on motion of Honorable Noe L. Endaya and unanimously seconded, it was;
