

RESOLUTION NO. 249 S-2019

A RESOLUTION REVOKING THE CERTIFICATE OF ACCREDITATION OF THE TWO (2) FACTIONS OF SORSOGON KINGCRAB RAISERS ASSOCIATION (SKRA), INC., REPRESENTED BY ITS PRESIDENTS MR. MANUEL F. EM AND MR. ALLAN ESPALLARDO, ISSUED BY THE SANGGUNIANG BAYAN THROUGH RESOLUTION NOS. 173 s - 2019 and 187 s - 2019, RESPECTIVELY.

WHEREAS, Sorsogon Kingcrab Raisers Association (SKRA), Inc. is a Civil Society Organization based locally and registered by the Securities and Exchange Commission under SEC Registration No. CN201333030 dated 29 August 2013;

WHEREAS, this CSO, due to internal dispute and disagreement among its membership, the organization was divided into two, each having a set of officers and members, however, bearing the same SEC Registration Numbers and both claiming to be legitimate;



WHEREAS, both factions, of Mr. Manuel F. Em and Mr. Allan Espallardo applied for accreditation with the Sangguniang Bayan and indeed both have been accredited under Resolution Nos. 173 and 187, respectively;

WHEREAS, the Sangguniang Bayan in the performance of its responsibility to accredit CSOs relied on its assessment to physical documents submitted to determine whether or not the CSO applicant is compliant of documentary requirements set forth by law, rules and regulations pertaining to accreditation, the Sangguniang Bayan once determine the completeness of the documents, its function to accredit becomes ministerial;

WHEREAS, for reason that there can be no two organizations, distinct and separate, bearing the same SEC Registration Numbers, conclusively, one is the legitimate and the other is not;

WHEREAS, the Sangguniang Bayan as a legislative body is not equipped with the skills of determining the veracity, authenticity and genuineness of a certain document in support of the application for accreditation, neither this Office is empowered to determine and has the authority to rule on the legitimacy of one against the other faction;

WHEREAS, both factions of SKRA are imputing derogatory records against each other, such deleterious attitude of leaders diminish the trust and confidence bestowed upon them by the government, thus, the organization has already remiss its capacity to promote the public interest and has already loss the identifiable leadership, membership and structure of a duly organized entity sustainable of achieving the common goal and objectives of the organization;


WHEREAS, both factions of SKRA has also noted to have exhibited misrepresentation and falsification, and imputation of derogatory records against each other, in support of the application for accreditation, thus, warrant the revocation of their Certificate of Accreditation in this Office;

NOW THEREFORE, on motion of Honorable Alvin E. Rosales and duly seconded by Honorable Aiza E. Encinares, Honorable Kenneth D. Escandor and Honorable Valentin A. Pura IV, it was;

RESOLVED, as it is hereby resolved to revoke the Certificate of Accreditation of the Two (2) Factions of Sorsogon Kingcrab Raisers Association (SKRA), Inc., represented by its Presidents Mr. Manuel F. Em and Mr. Allan Espallardo, issued by the Sangguniang Bayan through Resolution Nos. 173 s - 2019 and 187 s - 2019, respectively;

RESOLVED FURTHER, that this revocation maybe lifted, and accreditation revived, in favor of one of the factions, upon presentation of evidences and documents certifying its legitimacy including its officers and members, issued by proper authorities;

RESOLVED FURTHERMORE, that this resolution be furnished the Presidents of SKRA factions; the Securities and Exchange Commission (SEC), Regional Office No. 5; the Office of the Municipal Mayor; the Municipal Development Council (MDC) Secretariat; the Department of the Interior and Local Government - MLGOO Office, and other concerned offices for their information and guidance.
