

RESOLUTION NO. 25 S-2020

A RESOLUTION RESPECTFULLY REQUESTING FUNDING ASSISTANCE FROM HONORABLE MA. BERNARDITA B. RAMOS, REPRESENTATIVE, 2ND CONGRESSIONAL DISTRICT, PROVINCE OF SORSOGON, IN THE AMOUNT OF SIX MILLION PESOS (Php. 6,000,000.00) INTENDED FOR THE CONSTRUCTION OF 200 LINEAR METER SEAWALL BETWEEN PORTION OF THE COASTLINE OF BARANGAYS PINONTINGAN AND PANGANIBAN, ALL OF GUBAT, SORSOGON.

WHEREAS, along the coastline of Barangays Pinontingan and Panganiban, a limited length of coastal road was already constructed but leaving some portion thereof vacant particularly situated between the boundaries of the two (2) barangays;



WHEREAS, it has been observed that during high tides and heavy rains, said remaining vacant portion is now being flooded and consequently its heavy flow and current extends to the residential houses, and therefore the lives and property of residents thereat are dangerously at risk particularly during typhoons, storm surges and sea level rise;

WHEREAS, the construction of seawall along this vacant shoreline was perceived by this local government unit as a remedial measure to address the problem despite its limited financial capacity considering that huge amount is needed to fund its construction;

WHEREAS, considering further that the local development funds of the Local Government Unit of Gubat for this year were already allocated to other priority developmental projects of this municipality, there is a need to source out funds from national agencies/offices concerned to make this project tenable;


NOW THEREFORE, on motion of Honorable Danilo J. Pura and unanimously seconded, it was;

RESOLVED, as it is hereby resolved, to respectfully request funding assistance from Honorable Ma. Bernardita B. Ramos, Representative, 2nd Congressional District, Province of Sorsogon, in the amount of Six Million Pesos (Php.6,000,000.00) intended for the construction of 200 linear meter seawall between and portion of Barangays Pinontingan and Panganiban, all of Gubat, Sorsogon;


RESOLVED FURTHER, that copy of this resolution be furnished Honorable Ma. Bernardita B. Ramos, Representative, 2nd Congressional District, Province of Sorsogon, House of Representatives, Batasan Hills, Quezon City, for her gracious consideration and approval; and all other offices concerned for their information and guidance.
