RESOLUTION NO. 264 S- 2019

A RESOLUTION DECLARING THE MUNICIPALITY OF GUBAT, PROVINCE OF SORSOGON UNDER THE STATE OF CALAMITY DUE TO DAMAGE AND DESTRUCTION CAUSED BY TYPHOON "TISOY" THEREBY AUTHORIZING HONORABLE SHARON ROSE G. ESCOTO, MUNICIPAL MAYOR TO DISBURSE FROM THE FIVE (5%) PERCENT CALAMITY FUND AND FOR OTHER PURPOSES.

WHEREAS, on 02 December, 2019, the Municipality of Gubat was struck by Typhoon "Tisoy" leaving immeasurable damage to agriculture, infrastructure, property and other sources of livelihood that is anticipated to cause immense impact to socio-economic well-being of the Gubatnons;



WHEREAS, as per available data on the assessment of the extent of damage reveals P 221,132,670.00 in agriculture and fishery; P 14,350,000.00 in infrastructure; 198 total damaged dwellings; 873 partially damaged dwellings; and with an estimated 1,576 evacuated families or 3,620 individuals thus, there is an urgent need to provide relief and rehabilitation effort for those affected;

WHEREAS, as provided for under Republic Act 7160 otherwise called the Local Government Code of 1991. Specifically Section 324, Paragraph d, that Five (5%) Percent of the estimated revenue from regular sources shall be set aside as an annual lumpsum appropriation for unforeseen expenditures arising from the occurrence of calamities;

WHEREAS, Republic Act No. 10121 provides that, as per recommendation of the Local Disaster Risk Reduction and Management Council (LDRRMC), the concerned sangguniang may declare the municipality/city/province under the state of calamity;


NOW, THEREFORE, on motion of Honorable Aiza E. Encinares and unanimously seconded, it was;

RESOLVED, as it is hereby resolved to declare the Municipality of Gubat, Province of Sorsogon under the State of Calamity due to damage and destruction caused by Typhoon "Tisoy" thereby authorizing Honorable Sharon Rose G. Escoto, Municipal Mayor to disburse from the Five (5%) Percent calamity fund and for other purposes;

RESOLVED FURTHER, that copies of this resolution be furnished Honorable Sharon Rose G. Escoto, Municipal Mayor;, Gubat, Sorsogon; Honorable Francis Joseph G. Escudero, Provincial Governor, Capitol Compound, Sorsogon City; Ms. Ma. Luisa Dometita, MLGOO - DILG, Gubat, Sorsogon; all 42 Barangay Captains; the Finance Committee of the municipality, and all other offices concerned for their information and appropriate action;
