RESOLUTION NO. 27 S - 2020

A RESOLUTION RESPECTFULLY REQUESTING FUNDING ASSISTANCE FROM HONORABLE MA. BERNARDITA B. RAMOS, REPRESENTATIVE, 2ND CONGRESSIONAL DISTRICT, PROVINCE OF SORSOGON, IN THE AMOUNT OF NINE MILLION PESOS (Php. 9,000,000.00) INTENDED FOR THE REHABILITATION OF EXISTING SEAWALL AND FOR THE CONSTRUCTION OF 300 LINEAR METER ADDITIONAL SEAWALL ALONG THE COASTLINE OF BARANGAY BAGACAY, GUBAT, SORSOGON.

WHEREAS, it is the prime duty of the Local Government Unit of Gubat to protect and secure its inhabitants from the hazardous effect of natural calamities;

WHEREAS, Bagacay, Gubat, Sorsogon belongs to a mostly affected barangay in times of natural disasters for being one of the coastal barangays, and a calamity pruned area of this municipality that paved the way of rehabilitating the existing seawall and reconstruction of additional seawalls along its coastline;

WHEREAS, strong sea waves from the Pacific Ocean continue to erode unprotected coastal lands in the said barangay threatening numerous residential areas and agricultural lands;

WHEREAS, there is a pressing need to continue the construction of additional seawall and that time is of the essence to prevent further destruction of the coastal lands and loss of lives and properties in the event of natural disasters brought about by climate change due to global warming;

WHEREAS, the Local Government Unit of Gubat, Sorsogon is persistent enough to raise fund from outside sources to finance said rehabilitation and construction of seawall for this barangay;


NOW THEREFORE, on motion of Honorable Danilo J. Pura and unanimously seconded, it was;

RESOLVED, as it is hereby resolved, to respectfully request funding assistance to Hon. Ma. Bernardita B. Ramos, Representative, 2nd Congressional District, Province of Sorsogon, in the amount of Nine Million Pesos (Php.9,000,000.00) intended for the rehabilitation of the existing seawall and construction of 300 linear meter additional seawall along the coastline of Barangay Bagacay, Gubat, Sorsogon;
