### RESOLUTION NO. 29 S-2020

A RESOLUTION RESPECTFULLY REQUESTING FUNDING ASSISTANCE FROM HONORABLE MA. BERNARDITA B. RAMOS, REPRESENTATIVE, 2<sup>ND</sup> CONGRESSIONAL DISTRICT, PROVINCE OF SORSOGON, IN THE AMOUNT OF SIX MILLION PESOS (Php. 6,000,000.00) INTENDED FOR THE CONSTRUCTION OF 200 LINEAR METER SEAWALL BETWEEN PORTION OF THE COASTLINE OF BARANGAYS BALUD DEL NORTE AND COTA NA DACO, ALL OF GUBAT, SORSOGON.

WHEREAS, from the coastline of Barangay Balud del Sur and extending to the portion of Balud del Norte, a limited length of coastal road was already constructed, however, the construction did not completely cover the whole shoreline facing Balud del Norte and Cota na Daco, thus, leaving the coastline of the latter barangays open and vulnerable to floods and other hazardous effects of natural calamities;

WHEREAS, fronting the coastline of barangays Balud del Norte and Cota na Daco are closely residential areas, and its location is considered defenseless to any hazardous impact of sea wraths, thus, there is a need for this local government unit to come up with a solid preventive measure to avoid and/or at least mitigate this impact;

WHEREAS, the Local Government Unit of Gubat came up with the project seawall that will serve as protective measure against storm surge and increasing coastal erosion, making the residents living along the shoreline feel safer, and that this will serve further protection to different establishments near the town proper from destruction;

WHEREAS, the realization of this project is dependent on positive financial assistance from national offices/agencies to this local government unit, thus, this resolution seeking funding assistance;

NOW THEREFORE, on motion of Honorable Danilo J. Pura and unanimously seconded, it was;


RESOLVED, as it is hereby resolved, to respectfully request funding assistance from Honorable Ma. Bernardita B. Ramos, Representative, 2<sup>nd</sup> Congressional District, Province of Sorsogon, in the amount of Six Million Pesos (Php.6,000,000.00) intended for the construction of 200 linear meter seawall between portion of Barangays Balud del Norte and Cota na Daco, all of Gubat, Sorsogon;

RESOLVED FURTHER, that copy of this resolution be furnished Honorable Ma. Bernardita B. Ramos, Representative, 2<sup>nd</sup> Congressional District, Province of Sorsogon, for her kind consideration and generous action; and all other offices concerned for their information and guidance.
