A RESOLUTION SUSPENDING THE MOTORIZED TRICYCLE OPERATOR'S PERMIT (MTO) IN THE MUNICIPALITY OF GUBAT OF FAUSTINO F. ESTREVILLO WITH CASE NUMBER 05-09-2091 FOR A PERIOD OF ONE (1) YEAR STARTING THIS MONTH OF FEBRUARY 2019.

WHEREAS, the Code of General Ordinances of the Municipality requires that any operator wishing to suspend service for more than one (1) month should apply in writing, subject to approval of the sangguniang bayan;

WHEREAS, the above-named applicant applied before this office for the suspension of their MTO for reason that their public-utility-tricycle is under repair;

WHEREAS, the sangguniang bayan finds the request for suspension to be proper and reasonable;

NOW, THEREFORE, on motion of Honorable Cesar D. Esperida, Jr. and duly seconded by Honorable Valentin A. Pura IV and Honorable Ramilo S. Fajardo, it was;


