RESOLUTION NO. 33 S-2019

A RESOLUTION DECLARING AS VALID AND ENFORCEABLE, BARANGAY CARRIEDO ORDINANCE NOS. 2018-001, 2018-002, 2018-003, 2018-004, 2018-005, 2018-006 AND 2018-007.

WHEREAS, Barangay Carriedo has enacted the following regulatory ordinances numbered and titled as follows, to wit:

a. Brgy. Ordinansa No. 2018-001, "Kautusan ng Paglalagay ng Basurahan sa Bawat Tindahan na Nasasakupan ng Barangay Carriedo, Gubat, Sorsogon";

b. Brgy. Ordinansa No. 2018-002, "Kautusang Pagbabawal ng Pagtatapon ng Basura at Dumit sa Kailogan at Kung Saan Paman na Nasasakupan ng Barnagay Carriedo, Gubat, Sorsogon";

c. Brgy. Ordinansa No. 2018-003, "Kautusang Pagbabawal ng Paginom ng Alak sa Harap ng mga Tindahan o Pamublikong Lugar Tulad ng Waiting Shed, Harap ng Simbahan at Eskwelahan na Nasasakupan ng Barangay Carriedo, Gubat, Sorsogon";

d. Brgy. Ordinansa No. 2018-004, "Kautusang Pagpapatupad ng Curfew Hours sa mga Kabataan Edad 18 Anyos Pababa sa Lahat ng Pamublikong Lugar Tulad ng Kalsada, Waiting Shed, Harapan ng mga Tindahan, Video House at Tulay na Nasasakupan ng Barangay Carriedo, Gubat, Sorsogon";

e. Brgy. Ordinance No. 2018-005, "An Ordinance Prohibiting the Presence of Astray Animals in all Public Places within the Barangay of Carriedo, Gubat, Sorsogon":

f. Brgy. Ordinansa No. 2018-006, "Ordinansa sa Pag-imponer sin mga Regulasyunes Manongod sa Pag-usar san mga Pathway/Foothpath na Sakop san Hurisdiksyon san Barangay Carruiedo, Gubat, Sorsogon"; and

g. Brgy. Ordinansa No. 2018-007, "Ordinansa na Pagbabawal ng Pagpasok ng Anumang Uri ng Sasakyan sa Loob ng Paaralan, Pagparada ng Sasakyan sa Labas ng Paaralan at Malapit sa Gate, at Pagbabawal ng Pagtitinda sa Gate ng Paaralan at Tabi ng Kalsada, Para sa Maayos, Matiwasay at Seguredad ng mga Mag-aaral ng Carriedo, Elementary School".

WHEREAS, Article 3, Section 391 (a) of the Local Government Code of 1991 states that, "The Sangguniang Barangay, as the legislative body of the barangay shall (1) enact ordinances as may be necessary to discharge the responsibilities conferred upon it by law or ordinance and to promote the general welfare of the inhabitants thereon";

WHEREAS, Section 447, par. (a), subpar. (1) the Sangguniang Bayan has the power and duties to "approved ordinances and pass resolutions necessary for an efficient and effective municipal government, and in this connection (i) Review all ordinances approved by the sangguniang barangay and executive orders issued by the punong barangay to determine whether these are within the scope of the prescribed powers of the sanggunian and the punong barangay;

WHEREAS, it has been found that in the enactment of the above-mentioned ordinances, proper procedure were observed and that the same are in consonance with the Local Government Code of 1991 and other pertinent laws and local ordinances;


