WHEREAS, Municipal Ordinance No. 2014-005 under Section 2 (Section 22 (a) (1) as amended provides that, the operator is allowed to apply for a substitution of unit using the same unexpired MTOP/POP;

WHEREAS, after the approval of the amendment of the provisions of the Code of General Ordinances the substitution of unit is allowed to the operators having an unexpired franchise or Motorized Tricycle Operators Permit (MTOP);


NOW, THEREFORE, on motion of Honorable Valentin A. Pura IV and duly seconded by Honorable Aiza E. Encinares, it was;
