

A RESOLUTION AUTHORIZING HON, SHARON ROSE G. ESCOTO, MUNICIPAL MAYOR, TO ENTER INTO MEMORANDUM OF AGREEMENT/UNDERSTANDING WITH THE PHILIPPINE PARTNERSHIP FOR THE DEVELOPMENT OF HUMAN RESOURCES IN THE RURAL AREAS (PhilDHRRA) AND WITH LINGAP PARA SA KALUSUGAN NG SAMBAYANAN (LIKAS), INC. REGARDING IMPLEMENTATION OF PROJECT CONSOLIDATING CSO NETWORKS FOR CITIZEN'S ENGAGEMENT TOWARD PARTICIPATORY AND ACCOUNTABLE GOVERNANCE FOR POVERTY REDUCTION PHASE 2 IN THE MUNICIPALITY OF GUBAT, SORSOGON.

WHEREAS, PhilDHRRA is implementing a project entitled Consolidating CSO Networks for Citizen's Engagement Toward Participatory and Accountable Governance for Poverty Reduction Phase 2 (CCCE-PAG PR 2) funded by European Union (EU) with



the goal that a strengthened and expanded constituency of citizens demanding for transparent and accountable governance will have a positive impact in improving service delivery of local government units (LGUs) in the different provinces of the country including Province of Sorsogon;

WHEREAS, LIKAS has been identified as an implementing NGO partner of this project in the Province of Sorsogon, and is willing to participate and support the implementation of the said project in the whole province;
