A RESOLUTION REQUESTING THE DEPARTMENT OF HEALTH THROUGH DR. ERNIE V. VERA, MD, MPH, CHA, CESO IV, OIC - REGIONAL DIRECTOR, DOH - REGIONAL HEALTH OFFICE V, TO ASSIGN ONE (1) PHYSICIAN UNDER THE DOH DOCTOR TO THE BARRIO PROGRAM IN THE MUNICIPALITY OF GUBAT, PROVINCE OF SORSOGON.

WHEREAS, the total population of the Municipality of Gubat as of 2015 Philippine Statistics Authority record is 59,349 (13,471 Households) and there are only Two (2) physicians in the Rural Health Unit in the person of Dr. Anthony S. Lelis, the Municipal Health Officer (MHO) and Dr. Mari - Ann Pura Ecleo, assigned in the Doctor to the Barrio Program;

WHEREAS, the standard ratio of physician to population in the LGU Health Scorecard is 1:20,000 thus, the municipality needs Three (3) physicians in order to adequately provide the delivery of quality health services to the Gubatnons;


NOW THEREFORE, on motion of Hon. Valentin A. Pura IV and duly seconded by Hon. Cesar D. Esperida, Jr., it was;
