

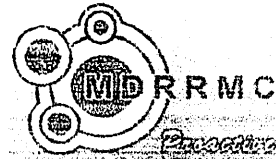

MDRRMC RESOLUTION NO. 2, S-2019

**A RESOLUTION APPROVING THE REPROGRAMMING OF THE
UNEXPENDED LOCAL DISASTER RISK REDUCTION AND MANAGEMENT
FUND (LDRRMF) AMOUNTING TO EIGHT MILLION SEVEN HUNDRED**

EIGHTY-NINE THOUSAND SIX HUNDRED FORTY-EIGHT PESOS AND 65/100 (8,789,648.65).

WHEREAS, Section 21 of RA No. 10121 states that the Local Calamity Fund shall be known as Local Disaster Risk Reduction Management Fund (LDRRMF). Not less than five percent (5%) of the estimated revenue from regular sources shall be set aside as the LDRRMF to support disaster risk management activities;

WHEREAS, the Commission on Audit (COA) requires the preparation of LDRMMFIP as a requirement for the release and use of LDRRMF per Circular No. 2012-002;

WHEREAS, Sec. 5.1.2 of said COA Circular states that the LDRRMFIP shall include the list of projects and activities charged to the unexpended LDRRMF of previous years.


WHEREAS, there is a joint certification from the Municipal Accountant and Municipal Treasurer stating the availability of the Local Disaster Risk Reduction and Management Fund;

NOW THEREFORE, on unanimous accord be it:

RESOLVED, as it is hereby resolved to approve the reprogramming of the unexpended 2018 LDRRM Fund.

RESOLVED FURTHER, to provide all concerned copies of this resolution for their information and appropriate action.




