A RESOLUTION APPROVING THE REPROGRAMMING OF THE UNEXPENDED LOCAL DISASTER RISK REDUCTION AND MANAGEMENT FUND (LDRRMF) AMOUNTING TO THREE MILLION FIVE HUNDRED TWENTY THOUSAND ONE HUNDRED EIGHTY-FOUR AND 13/100 PESOS (P 3,520,184.13) AS PER RECOMMENDATION OF MDC EXECOM UNDER RESOLUTION NO. 4, S-2020.
