### RESOLUTION NO. 57 S - 2019

A RESOLUTION SUPPORTING THE STRICT IMPLEMENTATION OF EXECUTIVE ORDER NO. 51, S-1986, KNOWN AS "THE NATIONAL CODE OF MARKETING BREASTMILK SUBSTITUTES, BREASTMILK SUPPLEMENTS AND OTHER RELATED PRODUCTS" IN THE MUNICIPALITY OF GUBAT, SORSOGON.

WHEREAS, the Local Government Unit of Gubat adopts the policy of the State in ensuring the safety and adequate nutrition for infants, and that there is a need to protect and promote breastfeeding and to inform the public about the proper use of breastmilk substitutes and supplements and other related products;

WHEREAS, it is significant that the public should be informed of the risk associated with the use of breastmilk substitutes and supplements and other related products through an adequate, consistent and objective information and appropriate regulation of the marketing and distribution of substitutes, supplements and other related products;

WHEREAS, there is a need for this local government unit to create enabling environment to support breastfeeding mothers and help them maintain breastfeeding as their feeding practice, and likewise support pregnant women to have an informed decision on what feeding practice they will chose for their infants, thus, awareness via strict implementation of Executive Order No. 51, S-1986 in this municipality is of significant;

NOW THEREFORE, on motion of Hon. Valentin A. Pura IV and duly seconded by Hon. Ramilo S. Fajardo, it was;




